<u>Cancellation/Refund Policy for In Person Registrations</u>

Refund requests must be received in writing to kcampbell@orkaevents.com.au and eligibility for a refund will be based on the following criteria:

- Requests received 21 business days prior to the event are entitled to a full refund less the administration fee of \$50.00.
- Requests received 14-20 business days prior to the event are entitled to a 50% refund less the administration fee of \$50.00.
- Requests received less than 14 business days prior to the event shall not be entitled to a refund or credit note.

If circumstances arise that force the FSC to cancel the face-to-face component of the event then a partial refund of your registration fee will be offered to convert your paid ticket to a virtual registration.

Refunds will be processed using the same method originally used to pay for your purchase.

Cancellation/Refund Policy for Virtual Registrations

Refund requests must be received in writing to kcampbell@orkaevents.com.au and eligibility for a refund will be based on the following criteria:

- Requests received 14 business days prior to the event are entitled to a full refund less the administration fee of \$50.00.
- Requests received 7-13 business days prior to the event are entitled to a 50% refund less the administration fee of \$50.00.
- Requests received less than 7 business days prior to an event shall not be entitled to a refund or credit note.

If circumstances arise that force the FSC to cancel the virtual component of the event then a full refund of the registration fee will be offered.

Refunds will be processed using the same method originally used to pay for your purchase.
